2. The jurisdictional Pr. Commissioners/Commissioners are requested to ensure that the officers who have been included in the Agreed/O.D.I. lists, including all the officers against whom disciplinary cases are pending or have otherwise come to adverse notice of the department, are not posted to sensitive charge. The Pr. Commissioners/Commissioners from whose charge such officers are transferred out shall immediately provide such information in respect of the officers in the above categories to the Pr. Commissioners/ Commissioners under whose charge the officer is under order of posting.

3. Officers posted to Customs will be allocated Commissionerates (viz Customs Amritsar or Customs Ludhiana) by the Chief Commissioner, Customs (Prev.) Zone, Delhi.

4. The jurisdictional Pr. Commissioners/ Commissioners are requested to issue Intra-Commissionerate transfer/placement orders by **05.05.2023**. While doing so, jurisdictional Pr. Commissioners/ Commissioners may rotate the officers whose tenure in a particular station is complete as prescribed in Para 6.12 of the transfer guidelines dated 17.01.2018. The Jurisdictional Pr. Commissioner / Commissioner shall further ensure that officers who have been allowed retention in the respective Commissionerates, are not continued in the same Division or continued in the same charge.

5. Officers posted to Directorates on loan/local transfer basis are for an initial period of 2 years from the strength of Chief Commissioner Office, GST, Chandigarh Zone and as per Board's letter dated 16.06.2017, the salary of these officers, will be drawn from

the budgetary head of the CCO & they will not be entitled to any special pay/deputation allowance.

6. The officers mentioned at Sr. Nos. 48-73, are not entitled for any Joining Time or T.T.A., as their transfers have been ordered at their own request and they have been accommodated as far as administratively possible. However, if any of these officer is aggrieved with this pre-mature transfer on request and not willing to join their new place of posting, such officer shall make a request in writing before the Chief Commissioner, CGST Zone, Chandigarh, latest by **26.04.2023**, and shall email a scanned copy of the request on the email Id of CCU – ccu-cexchd@gov.in. A copy of the request shall also be forwarded to the CCU office through proper channel, with the approval of the jurisdictional Pr. Commissioner / Commissioner.

7. All the representations, received till date, are disposed of accordingly. No fresh representation shall be considered unless the officers join their new place of posting.

8. Representation, if any against this order will only be considered if it has been forwarded by the Commissionerate with the express approval of the Pr. Commissioners/ Commissioner. No "Advance copy/ direct representations" will be entertained.

9. All officers shall be relieved by **12.05.2023**, failing which they shall be treated as stand relieved.

10. This issues with the approval of the Chief Commissioner.
