Kind attention of all the suppliers of goods and services, members of trade and industry and others concerned is invited to Circular No 17/17/2017-GST dated 15.11.2017 issued vide F No 349/169/2017-GST and Circular No 24/24/2017-GST dated 21.12.2017 issued vide F No 349/58/2017-GST by the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, GST Policy Wing on the subject cited above.

The department has launched a Special Drive from 31.05.2018 to 14.06.2018 to eliminate the pendency of Refund applications received upto 30.04.2018.
